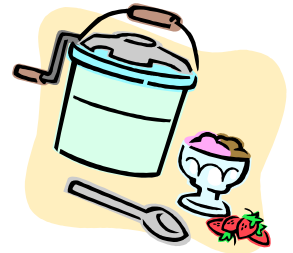

- Contestants **MUST** furnish ingredients, utensils, ice cream freezers (manual or electric drop cords), cups and spoons for tasting, **a table for display**, table covering and rock salt. **Ice will be provided.**
- Contestants must arrive at the Fair Grounds by **3:00 pm**, October 2. Churning will begin at **3:30pm**.
- All recipes must contain dairy products. **No** raw eggs or raw milk are allowed in the final product.
- Ice cream mix must be made ahead and kept chilled until churn-off begins.
- Entries will be judges on flavor, texture, originality and presentation of the final product.
- Contestants will be required to taste their finished product before judging begins.
- Judging will begin at **4:45 p.m.** We will have two official judges. First, second and third place prizes will be awarded for youth and adult categories.
